## WORKSHOPS

### Introduction to Amnesty International

This workshop will give a brief overview of Amnesty International—how to get involved, what we do as activists, the volunteer leadership structure, where to go for information, and what all those acronyms stand for.

### Afghan Refugee Crisis and Issue of Asylum Seekers

This workshop will discuss the challenges of resolving Afghanistan's internal refugee problems, refugee populations in Iran and Pakistan, and the issue of asylum seekers still not granted the right to stay in Australia, Japan, Europe, and North America.

#### **Death Penalty Workshop**

There is a major effort headed by Death Penalty Focus of California to get local governments to adopt death penalty moratoriums. Several cities, including Sacramento and San Francisco, have adopted such a resolution. This workshop will primarily be concerned with what you can do to get a moratorium adopted in your community.

### Military Ethics as a Source of Human Rights

## Lawrence P. Rockwood, AIUSA Military, Security & Police Working Group

Military ethics, derived from just war tradition, comprises one of the two historical foundations of human rights, the other being international law derived from natural law theory. Just war tradition is primarily associated with St. Augustine who, after the christianization of the western Roman Empire in 476 AD argued that it was possible "to please God while engaged in military service." The international law foundation is primarily associated with Hugo Grotius who secularized just war theory in the seventeenth century and attempted to establish a code of legalistic proscriptions affecting the conduct of nations. Modern expressions of just war principles include the Lieber Code issued during the American Civil War and the Nuremberg principles established after World War II. Conversely, modern expressions of international legalism include the Geneva Conventions and the establishment of the International Red Cross. Augustine's primary concern was the justice of the decision to initiate war (*jus ad bello*). However, he and later just war theorists were also concerned with just conduct in war (*jus in bello*). Just war theory continues to enable individuals of diverse backgrounds to engage in an interdisciplinary dialogue on the humanitarian

consequences of war by providing a common language. The talk will end with a brief discussion of the relationship between the military profession and the human rights community in general and Amnesty International in particular.

### Affirming Human Rights through Public Health

Gabriella Miotto, M.D., The Children's Clinic

Through a slide show presentation focussing on Chiapas, Mexico, Guatemala, Macedonia, Kosovo, and South Africa, we will ponder issues of human rights violations both abroad and in the USA, and the challenging role of public health in upholding basic human rights.

#### **Organizing and Planning Events**

#### Mario Tafur, AIUSA Western Regional Membership Program Coordinator

This workshop will discuss some of the elements that go into organizing and planning an event. Events are a very important part of engaging the community and getting them interested in Amnesty International's work. Hopefully this workshop will encourage you to feel more comfortable in doing events in your community.

#### Human Rights in Post 9/11 America

#### Victor Condé, AIUSA Legal Support Network

This workshop will consist of a lecture describing in human rights terms and context what has happened in the US and in the "War Against Terrorism." It will describe events from the 9/11 attack to the attack in Afghanistan; the status, arrest and trial of Taliban and Al Quaeda prisoners; the Executive Order on military tribunals; the passage of the US Patriot Act legislation; the arrest and detention of suspects in the US; the US and the proposed Internaional Criminal Court; and how the "War on Terrorism" will affect human rights for Americans. Questions and discussion will follow.

## PRESENTERS

## **Rachel Ackoff**

Rachel Ackoff is currently attending Claremont High School and has been coordinator for the past two years of her campus Amnesty group. She is the Student Area Coordinator (SAC) for her surrounding area. In addition, she is one of the Sierra Club's Student Coalition coordinators.

### Ali Azizi

Ali Azizi joined Amnesty International when he was a student at UCLA in the 80's and has been active since then. He has served Amnesty in many different capacities: group coordinator, case coordinator, area coordinator, cogroup member, member of various task forces, and, most recently, Board member since 2000. He is originally from Iran and has a degree in physics.

#### **Christopher Calhoun**

Christopher Calhoun is Deputy Director for Public Policy of ACLU of Southern California. He is a full-time activist for civil and human rights and has worked on several successful campaigns for the ACLU.

#### Victor Condé

Victor Condé is a lawyer and professor of international law and human rights at Trinity Law School. He is an expert on international and comparative human rights and humanitarian law and international criminal law. Professor Condé is part of the AIUSA Legal Support Network and the AIUSA Human Rights Education Network for the Western Region. He is the author of A Handbook of International Human Rights Terminology, published in 1999 and Human Rights in the United States: A Dictionary and Documents, published in 2000. The latter book features a forward by Bill Schulz, AIUSA Executive Director.

#### **Tracy Gore!**

Tracy Gore! is currently the chair of Amnesty International's Greater Los Angeles Area Development (GLAD) group, which coordinates the activities of a cluster of local AI community groups.

#### **Darcie Guy**

Darcie Guy has been involved in Amnesty for 6 years, during which time she has served as coordinator of Group 178 Irvine, Orange County Area Coordinator, and member of the Western Regional Planning Group. She serves as co-chair for the Run for Freedom.

#### Deidre Jackson

Deidre Jackson has been a volunteer for Amnesty International for twenty years, both in local community groups and for ten years as a trainer for the Western Region. She has worked as a case coordinator for prisoners in Nepal, Burma and Syria and assisted in cases in the former Soviet Union and Benin, West Africa.

# Gabriella Miotto

Gabriella Miotto currently works in family medicine at The Children's Clinic, a private non-profit in Long Beach. She has had the opportunity to work with the UNHCR, PROSECO, Doctors of the World, and the Alaska Native Tribal Health Consortium. She loves travel, flamenco, and poetry.

## Lawrence Rockwood

"Captain" Lawrence Rockwood is a former US Army intelligence officer court-martialed for exposing his former military command's dereliction of duty during Operation Restore Democracy in Haiti in 1994. In that operation, his commanding general refused to recognize international human rights norms and official US military doctrine by refusing to account for political prisoners being held by a collapsing repressive military dictatorship. AIUSA was instrumental in his receiving pro bono legal representation by former US Attorney General Ramsey Clark. Since his separation from the service he has served as a Fellow for the Center for International Policy, a consultant for the Institute for Policy Studies, and a member of Amnesty International's Military, Police, and Security Working Group. While accepting speaking engagements at numerous military forums on military ethics and human rights, he is presently an adjunct professor in the history department at California State University at San Marcos. He and his wife, Dr. Amelia Simpson, are co-authors of a forthcoming book on human rights and military professionalism.

## Tim Spann

Tim Spann has been a member of AI for more than 10 years and was coordinator of Group 137 for seven years. He is also one of the California State Death Penalty Coordinators for AI as well as a member of Death Penalty Focus.

## Mario Tafur

Mario Tafur started volunteering with Amnesty International in 1987 as a part of Chaparral High School's student chapter. In the summer of 1990, he participated in Amnesty's Asylum Summer program which took 11 students from around the country to Southern Texas to work with law offices doing political asylum work. After completing graduate school in Southern Arizona, he moved to Los Angeles and began working for the Western Region as the Ralph J. Bunche Fellow. He has been the Membership Program Coordinator for the Western Region Los Angeles office for the past two years.

## Martha Ter Maat

Martha Ter Maat is a member of AIUSA Group 22 Pasadena/Caltech and a member of the Steering Committee for the Human Rights Educators Network in the Western Region.
