## Myanmar: Amnesty Calls for Independent Investigation of Violent Attack Against Aung San Suu Kyi and Supporters

In a report released July 29, Amnesty International called on the Myanmar government to permit an independent investigation into the physical attack that occurred exactly two months ago against National League for Democracy (NLD) leaders, and to prosecute those responsible. The report, presented to Myanmar government officials, calls for the immediate and unconditional release of Daw Aung San Suu Kyi, NLD General Secretary, U Tin Oo, NLD Vice-Chairman, and all other NLD members and supporters arrested for peacefully expressing their political views. The report also calls on officials to clarify the whereabouts of those who are missing or have been in detention since the May 30 attack.

"The Myanmar government's stranglehold on political opposition was crudely put on display by the recent violent attack against National League for Democracy members," said T. Kumar, Asia Advocacy Director for Amnesty International USA. "Amnesty International welcomes the US government's condemnation of the attack and arrests, and calls on US officials to urge Yangon to permit an independent, impartial, and prompt investigation into the physical attack and bring those responsible to justice."

In the new report, *Justice on Trial*, Amnesty International outlines its concerns about the administration of justice in Myanmar, highlighting correspondence between the human rights organization and the State Peace and Development Council (SPDC), Myanmar's military government. Major concerns include: arrest and pre-trial detention; torture and ill-treatment; trials of political prisoners; laws in force relating to human rights; prison conditions; and mechanisms for the investigation of human rights violations. The report also provides detailed recommendations to the government about justice system reform.

"The attacks against the NLD send an urgent message that impunity must end in Myanmar," said Kumar. "The justice system must be significantly reformed for the people of Myanmar to enjoy even basic human rights protections."

An unknown number of people are still detained or missing in the aftermath of the May 30 attack, although—in a welcome development—the SPDC announced on July 23 that 91 people arrested in the May 30 violence had been released. However, more than 1,300 political prisoners remain in Myanmar's prison system, sentenced in trials that fall short of international fair trial standards by laws that effectively criminalize

the right to freedom of expression.

In the interest of finding a solution to the human rights crisis in Myanmar, Amnesty International supports the work of Ambassador Razali Ismail, the UN Secretary General's Special Envoy, and Professor Paulo Sergio Pinheiro, the UN Special Rapporteur on Myanmar. It urges the SPDC to cooperate fully with them in the fulfillment of their mandates.




