# Ethiopia: Special Focus Case Mesfin Woldemariam Released

On July 20, after months of campaigning by Amnesty International, 38 Ethiopian opposition party officials, prominent human rights defenders, and journalists were released. The 38 were detained and imprisoned in connection with public demonstrations protesting alleged election fraud. Amnesty International considered most, if not all, to be prisoners of conscience. The group included:

- Professor Mesfin Woldemariam, founder and first president of the Ethiopian Human Rights Council and one of Amnesty International's Special Focus Cases;
- Dr. Berhanu Nega, elected Mayor of Addis Ababa and an economics professor; and
- Dr. Yacob Hailemariam, retired Norfolk State University law professor and former U.N. prosecutor at the International Criminal Tribunal for Rwanda.

The defendants were convicted on June 11 after a 14-month trial by the Federal High Court of Ethiopia. They refused to defend themselves insisting that their arrests, charges, detention and trials were politically motivated and that the trial was not likely to be fair. They were convicted on the basis of the prosecution evidence and prevented from making a statement in court after the prosecution case ended. The judge ruled that they had not submitted a defense and were guilty as charged, giving no reason for the sudden verdict. Ten co-defendants, including two civil society activists, Daniel Bekele and Netsanet Demissie, chose to defend themselves through counsel. Upon their release, the defendants received a pardon and had their political rights restored.

Mesfin Woldemariam is Ethiopia's most prominent human rights defender, respected for his integrity and tenacity. In early November 2005, authorities detained him on a variety of charges in connection with public demonstrations protesting alleged election fraud in the May 2005 elections in Ethiopia. The charges include "outrage against the Constitution," "obstruction of the exercise of constitutional powers," "inciting, organizing or leading armed rebellion" and "attempted genocide." If convicted, he could receive the death penalty. Amnesty International considers Professor Mesfin Woldemariam a prisoner of conscience and is calling for his immediate and unconditional release.

In 1991, Professor Mesfin founded the Ethiopian Human Rights Council (EHRCO), a non-governmental organization that investigates and reports on human rights violations in Ethiopia. While the government initially approved of EHRCO,

it has been increasingly hostile to the organization. Authorities detained six EHRCO staff members for several weeks in June 2005. Professor Mesfin was the organization's chair until 2005 when he resigned and joined the election campaign of the Coalition for Unity and Democracy (CUD), the main opposition party.

The group sent a total of 28 letters, including letters to Pakistani officials on behalf of Younis Masih, sentenced to death for blasphemy; to the Georgia State Board of Pardons on behalf of Troy Davis, sentenced to death but who may be innocent; to Myanmar officals on behalf of Ma Khin Khin Leh, sentenced to life imprisonment for planning a peaceful demonstration; and to Secretary of Homeland Security Michael Chertoff regarding the detention of migrant families in US detention facilities.

### Meeting with Julissa Gomez

The group discussed the recent meeting several members had with Julissa Gomez, AIUSA Western Region Field Organizer. As mentioned in last month's newsletter, among Julissa's top priorities are finding an Area Coordinator and a Student Area Coordinator for the area. Julissa also mentioned that there will be three main focuses of Amnesty in 2008: China, the death penalty, and the treatement of Native American women, as part of the Stop Violence Against Women Campaign.

Julissa pointed out that the LA office has a lot of commercial movies, such as Road to Guantanamo or Blood Diamond, that the groups can borrow. The groups have also been given more leeway to work with other organizations. In the past, we've been somewhat restricted in terms of the types of groups we can work with. Amnesty is moving email groups away from Yahoo to Google because of the case of Shi Tao, who was arrested after Yahoo provided information to Chinese authorities.

### China Campaign

Kevin threw out some ideas about events focusing on China, such as the Amnesty Olympics, with letter-writing or games modeling some of the human rights abuses taking place in China now, such as the destruction of houses. Kevin will try to coordinate some activities with the other groups. We could also try to plan an event at next year's Southern California Mini-Conference.

## Death Penalty News

Mary Kay told us about a man in Iran who was in jail awaiting execution for 11 years for adultery and was recently stoned to death, 125 miles west of Tehran. The woman has not been stoned yet. Mary Kay also told us about how the rules differ for stoning men and women (the woman is buried up to her neck, the man up to his waist). We also discussed the case of Troy Davis, who received a 90-day reprieve of execution. These cases and more were mentioned in the *Los Angeles Times* editorial "Killing Machine" on July 14, which calls for the end of state-sponsored killing. #### **Group History**

Thanks to Bobbi, Dagmar, and Jim for compiling a group history for the upcoming revamped website. We thought we would share it with you all here first.

Established in 1979, the Long Beach A.I. group has taken on long-term cases in which we have worked for the release of over a dozen prisoners of conscience (aka POCs) in Myanmar (aka Burma), Vietnam, Chile, Czechoslovakia (later the Czech Republic), Bulgaria, Romania, and Kosovo. Among the better-known POCs were Nobel Laureate Aung San Suu Kyi of Myanmar, Vaclav Havel of then-Czechoslovakia, and Nguyen Dinh Huy of Vietnam.

Since A.I.'s mission has expanded beyond the concern for prisoners of conscience and other political prisoners, the Long Beach group has worked on these additional areas:

- human rights campaigns focusing on world regions such as West Africa, Central Europe, and Southeast Asia;
- campaigns to end torture, the death penalty, violence against women, and abuses in the Global War on Terror, as well as working for children's rights and the rights of indigenous people;
- mailing thousands of letters, post cards and petitions over the years to governments on behalf of individuals at risk around the world, in addition to our regular work for our assigned individual prisoners of conscience;
- providing speakers to local organizations and schools;
- engaging with government officials, including our mayor and three members of Congress;
- holding dialogue with a major oil firm about the impact of its operations on human rights in Myanmar;
- conducting research on conditions of detention of asylum seekers while assisting some to validate their claims of asylum and to receive needed medical care; and
- persuading a local business to stop selling and exporting to military and police organizations a device known as thumb cuffs, which could be an instrument of torture.

#### Publicity

In addition to our local efforts (publicizing more at the church that hosts our meetings, the IUCC, and in local press outlets), we discussed the possibility of sending out postcards to national members in the city of Irvine and perhaps surrounding areas. Jacques will research the cost of printing a colour postcard that would entice people to come to our meetings, and find out from an Amnesty International office how many names we would get for Irvine and/or neighbouring cities. Dean suggested that that this publicity effort should be done in conjunction with a more important occasion than "just" a group meeting.

#### Actions

Jacques will be signing up for the Weekend of Faith in Action against the Death Penalty (19–21 October) and plans to have at least a table at his church, the Orange Coast Unitarian Universalist Church and, if possible, also at the IUCC.

Jacques also announced that he will be trying a small Amnesty letter-writing group at the OCUUC, providing letterwriting actions once a month between services.

The remainder of the meeting was spent identifying priority issues the group wants to focus on in the coming months. It was agreed that the ongoing War on Terror will remain a priority as will the Stop Violence Againt Women Campaign. The group also decided to adopt a prisoner of conscience at next month's meeting.




