## AI Charges China's Human Rights Record Risks Blighting Olympics Legacy

With one year to go before the Summer Olympics open in Beijing August 8, 2008 Amnesty International said time is running out for the Chinese Government to fulfill its promise to promote human rights as part of the Olympics legacy. In August Amnesty International released a new progress report: *China: The Olympics Countdown—One Year Left to Fulfill Human Rights Promises,* which focuses on four key areas of human rights relating to the Olympics: death penalty, detention without trial, human rights activists and media freedom.

"Unless the Chinese authorities take urgent measures to stop human rights violations over the coming year, they risk tarnishing the image of China and the legacy of the Beijing Olympics," said Irene Khan, Amnesty International's Secretary General.

Amnesty International members and other activists gathered in front of the Chinese Embassy in Washington, DC on August 8 to call on Chinese officials to improve their human rights record. China had agreed to improve its human rights record as a condition to receiving the bid.

The new report looks at China's progress toward its promised human rights improvements ahead of the Games. Amnesty International found that several Beijing-based activists continue to face 'house arrest' and tight police surveillance, while some activists in other parts of China are encountering heightened patterns of abuse as attention is focused on Beijing in the run-up to the Olympics. The briefing also highlights an ongoing crackdown on journalists, which has extended recently to the closure of certain Chinese civil society and development publications.

"The crackdown on human rights defenders and domestic media continues to overshadow more positive reforms with regard to the death penalty and foreign media coverage in China," said Khan. "Not only are we not seeing delivery on the promises that the Olympics would help improve the human rights situation in China, but the police are using the pretext of the Games to extend the use of detention without trial."

The report also highlights the continued use of detention without trial as part of the government's 'clean up' operations of Beijing ahead of the 2008 Games. The crackdown comes despite the fact that substantial reform or abolition of methods of arbitrary detention, including 're-education through labor,' has been on China's reform agenda for many years.

Amnesty International welcomes recent statements by Chinese Supreme Court officials expressing the need for greater

transparency on the death penalty and unified criteria for imposing death sentences. However, AI urged the authorities to broaden this approach by increasing access to information on individuals facing the death penalty, particularly for lawyers and members of their families, and by publishing full national statistics on death sentences and executions.

"The application of the death penalty in China—the world's top executioner—remains shrouded in secrecy," said Khan.

### August Meeting Minutes Group #596 Huntington Beach

Eight people attended our monthly meeting. The group adopted a prisoner of conscience, Magdalena Garcia Duran, an indigenous rights activist in Mexico. The group wrote letters of concern to the Mexican government and letter of support to Magdelana.

The other focus of our meeting was on torture and the war on terror. The group received a fact sheet on the prison at Guantanamo Bay, and we watched the docudrama *The Road to Guantanamo*. We signed a petition and wrote letters to President Bush calling for closure of the facilities at Guantanamo.

## August Meeting Minutes Group #141 Orange

#### Letters

The group sent letters to Sri Lankan officials regarding "disappearances" committed by Sri Lankan security forces in connection with the war between the government and the Liberation Tigers of Tamil Eelan and the insurrection in the late 1980s by the People's Liberation Front, as well as letters to officials in Saudi Arabia protesting the execution of minors there. The group also worked on the Summer Postcard Action.

#### Tabling

Jeannine reported that she has still had no response from the national office about insurance for tabling at the Artists Village Walk in downtown Santa Ana. The group is hoping to get it in time to table on Saturday, October 6.

#### Resolutions

Kevin discussed the AIUSA membership resolutions process. There is a new resolutions discussion board online. Kevin will bring a copy of the resolutions packet to the September or October group meeting for the group to discuss in advance of the regional meeting in San Francisco on November 9–11.

#### Yahoo Groups

Kevin reported that Amnesty is moving all of its online groups from Yahoo to Google because of Yahoo's actions in the Shi Tao case. Shi Tao is a Chinese journalist sentenced to a 10year prison sentence for engaging in pro-democracy efforts that the country's authorities deemed subversive. Yahoo and its former subsidiary, Yahoo Hong Kong, helped the investigation by providing China's authorities with personal information culled from the e-mail accounts and other online activities of Shi Tao and another journalist, Wang Xiaoning.

#### New Area Coordinator

Julissa Gomez, the Western Region Field Organizer, recently roped in Wendy Marshall to serve as the Area Coordinator for the Orange County and Long Beach groups. Wendy has been an Amnesty member for 20 years, first getting involved while in high school.

#### Planning Meeting Next Month

The group will be spending part of next month's meeting on planning for 2008. Kevin distributed some documents for members to look over before the meeting.

#### **Top Interests**

#### Website

**Holiday Party.** Interest was expressed in a holiday party this year and Norma volunteered her house. This is a good way to enjoy the social aspects of volunteering and also bring in new "friends of friends" and hopefully expand the active participants.

Next meeting suggested for mid-November, after the Regional Meeting. Let's shoot for Tuesday, November 13, and adjust as the date gets closer if need be.




